### Name of Work:

### Eligibility Criteria:

The contractor should have at least 5 years of similar experience.

### Scope of Work:

- 1) Supply & installation of temporary Mandap / waterproof shed suitable for the rainy season, complete with supporting structure such as poles etc.
- 2) Supply, installation & maintenance of electrical equipments with proper electrical cabling, wiring, switches with electrical safety compliance, as specified by electrical dept of State Government PWD Dept. The electrical equipments including ceiling fans pedestal fans, lighting fixtures, decorative lighting etc.
- 3) Dismantling & removal of setup post event and ensuring cleanliness of the area.
- 4) Entire electrical work needs to be carried out by PWD licensed electricians / Wiremen. After completion of electrical installation work the contractor will have to submit test report in prescribed form of State Government PWD Electrical Dept.
